**Awards:** Qualifying scores will receive a green ribbon; placement ribbons will be given for 1<sup>st</sup>- 4<sup>th</sup> place. Rosettes will be awarded for High In Trial, High Combined Score, High in Trial Junior Handler in Rally, and High Scoring Junior Handler in Obedience, High Score in each Rally Level (A&B classes only), High Score among all C classes. In Rally, Qualifying scores of 195 and higher will receive ribbons indicating an "X" qualifying score. No award ribbons will be mailed. Additional prizes may be awarded at affiliate's discretion. Obedience Trial will fill with 8 hours of judging per judge.  
Rally trial will fill at 120 runs per judge.

Obedience and Rally require separate entry forms. Please use the current entry forms located on the ASCA website. Please make sure entries are legible, correct and include jump height if required for class entered. Entrants are responsible for errors on entry forms and no entry fee will be refunded in the event of such errors. No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Entries received without proper fee payment will not be accepted. Returned checks do not constitute a valid entry, and an NSF fee of \$35 will be charged.

No bitches in season will be allowed to participate in any Obedience or Rally class during this trial.

Foreign entries must be paid with funds drawn on a U.S. bank or by money order. DO NOT SEND CASH.

For immediate confirmation of receipt, please enclose a stamped, self-addressed postcard. Confirmation of receipt does not constitute an accepted entry. Acknowledgment of entries will be made after close of entries.

Cancellation Policy: Cancellation of pre-entries must be made no later than August 30, 2018. No refunds will be given for requests postmarked or requested after August 30, 2018. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by action of the Show Committee or ASCA Board of Directors. If, because of riots, civil disturbances, or other acts beyond the control of management, it is impossible to open or complete the show, no refund of entry fees will be made.

Armbands may be picked up on Sunday, September 23, 2018, between the hours of 6:00pm – 8:00pm in the obedience/rally office or at 7:30am day of trial.

Move-up's can be made prior to September 10, 2018 via written notification through the mail or through email. Move-ups will also be accepted between 6:00pm and 8:00pm on September 23<sup>rd</sup> in the obedience/rally office. Move-ups will not be allowed the morning of the event.

NO CLASSES WILL BE JUDGED PRIOR TO THE POSTED TIMES ON THE SCHEDULES, BUT MAY START LATER. If you anticipate a ring conflict, PLEASE notify the steward at your ring of your conflict prior to the posted start time of your class. We will do our best to accommodate conflicts, but will not hold classes open longer than 15 minutes waiting for reported conflicts. Rings will not be held for exhibitors who have not checked in or have not reported a conflict prior to their posted ring time.
